The Terry Town Council held a public hearing for the purpose of hearing comment and consideration of Resolution # 2019-459, Specifying the Street Maintenance District # 1 Assessment Option and Levying and Assessing a Special Assessment for Fiscal Year 2020 Upon all the Property within Said District, to Defray the estimated Cost of Maintenance Within the Same. The Town Council held a final budget hearing for the purpose of hearing comment and consideration of Resolution # 2019-461, Adopting the Final Budget for Fiscal Year 2019-20 as well as consideration of Resolution # 2019-460, determining the salaries and compensation for fiscal year 2019-20. The following persons were in attendance: Council members Cindy Bond, Caryn Rein, Peter Leyva, and Brad Eaton as well as Clerk Lynn Schilling, Cheryl Berry, Jacob Kitsen, Donne and Dustin Stagg. Mayor Rolane Christofferson presided over the public hearing.

Mayor Rolane Christofferson called the meeting to order at 6:00 p.m. and led the Pledge of Allegiance.

Mayor Rolane Christofferson briefly discussed Resolution # 2019-459 and opened up the public hearing. Cheryl Berry inquired if all roads would be snowplowed and expressed that she felt her road had been rarely plowed in the past. She also inquired about taking more streets to gravel. Mayor Rolane Christofferson encouraged her to call Town Hall when she has street concerns such as snowplowing. Donne Stagg inquired about the budget for the street repairs by the hospital. She further inquired about the priority of street repairs within the budget. Dustin Stagg inquired about the use of crack-sealing and stated that he has equipment he would be willing to utilize. Donne Stagg inquired about widening gravel streets to which Mayor Rolane Christofferson discussed the process. Jacob Kitsen asked about structures that could be impacted. With no further questions or comments, the The Town Council passed a motion to adopt Resolution # 2019-459. (Bond/Rein)

Mayor Rolane Christofferson discussed Resolution # 2019-460, determining the salaries and compensation for fiscal year 2019-20. Jacob Kitsen asked what the raise amount was, to which Mayor Rolane Christofferson stated a COLA amount of 2.5 %. Mayor Rolane Christofferson stated that she is declining a raise as was previously discussed by the Town Council. The Town Council passed a motion to adopt Resolution # 2019-460. (Leyva/Bond)

Clerk Lynn Schilling provided updated budget documents to the Council members and members of the public present. The final budget document was available for viewing as well. Donne Stagg asked about the process for a voted levy in regards to the streets. Dustin Stagg inquired as to if town officials discuss issues with other little towns. Cheryl Berry asked if the town had looked at obtaining public water through Dry-Redwater. With no further questions or comments, the Town Council passed a motion to adopt Resolution # 2019-461 adopting the Final Budget for Fiscal Year 2019-20. (Rein/Eaton)

Having no further comment, questions, or public comment the public hearing was adjourned at 6:39 pm. (Leyva/Rein)
