The undersigned hereby applies for permission under the ordinances of the Town of Terry to construct a private wastewater disposal system. The Applicant represents to the Town of Terry that the waste water disposal system is being installed on the following property in Terry, Montana:

The applicant understands that, for the FIVE HUNDRED AND 00/100 DOLLARS (\$500.00) fee, the Town of Terry will provide a saddle to hook the wastewater disposal system to the public sewer system to the Town of Terry, and the Town shall provide the labor to hook the sewer to the main sewer line.

The Applicant agrees:

- 1) The access shall not be allowed until the installation of the private wastewater system is completed to the satisfaction of the Director of the Public Works of the Town of Terry or his authorized representative.
- 2) The Director of Public Works shall be allowed to inspect the work at any stage of construction, and, in any event, the Applicant for the permit shall notify the Director of Public Works when the work is ready for final inspection, and before any underground portions are covered. The inspection shall be made within seventy-two (72) hours of receipt of the notice by the Town. The connection and testing shall be made under the supervision of the Director of Public Works or his representative.

- 3) This is an application for residential or commercial service, and is not an application for service of disposal of industrial wastes.
- 4) All costs and expense incidental to the installation and connection of the building sewer shall be borne by the Applicant. The Applicant shall indemnify the Town of Terry from any loss or damage that may directly be occasioned by the installation of the building sewer.
- 5) The connection of the building sewer into the public sewer shall conform to the requirements of the building and plumbing code or other applicable rules and regulations of the Town of Terry, and the State of Montana.
- 6) All excavations for building sewer installation shall be adequately guarded with barricades and lights so as to protect the public from hazard. Streets, sidewalks, parkways, and other public property disturbed in the course of the work shall be restored in a manner satisfactory to the Town of Terry.
- 7) All sanitary sewer pipe and fitting shall be PVC SDR 35 or approved equivalent.
- 8) Any excavation into a street or alley within the Town of Terry shall be done in compliance with Chapter 12.04 et seq of the municipal code of the Town of Terry.
- 9) An application fee of FIVE HUNDRED AND 00/100 DOLLARS (\$500.00) accompanies this Application.
