The Terry Town Council met in session at 6:00 p.m. with Mayor Rolane Christofferson presiding. Council Members present were Neva Rathbun, Scott Christofferson, Tom Magalsky, and Karlene Kinsey. Also present were James Schilling, Clerk Lynn Schilling, Town Attorney Rennie Wittman, and Undersheriff Jon Arnold.

Mayor Rolane Christofferson called the meeting to order at 6:00 p.m. and led the Pledge of Allegiance.

Public Comment- None.

Minutes from the December 9th, 2021 meeting were approved. (Christofferson/Rathbun)

Claims approved per Claims Committee. (Kinsey/Magalsky)

Cash/Bank Reconciliation was approved. (Christofferson/Rathbun)

After review of the Stockman Bank Investment Fund account \$1,605.514.89 will be the amount in the Stockman Bank Investment Fund for the month of January. (Rathbun/Christofferson) Interest is deposited in the amount the end of each month. Unfinished Business

Clerk Lynn Schilling reported that Greg Steckler (Core Engineering) has calculated that the town will need approximately 130 acres for sludge application. Mayor Rolane Christofferson will discuss the possibility with the adjacent landowner.

Council Member Tom Magalsky reported that the fire department had completed a training utilizing the thermal imaging cameras that was very well received.

Prairie County Undersheriff Jon Arnold provided an update on public safety. He reported that things have been a bit quieter lately. New members of the Sheriff's Office are attending trainings with one member currently attending a training on DUI's. He discussed some noted issues of traffic safety at intersections in town. Mayor Rolane Christofferson stated that the vaccination clinic and dog registration is coming up so Clerk Lynn Schilling will be providing a new listing of registered dogs within town limits.

Regarding the Town/Fire Hall and the town shop, Clerk Lynn Schilling reported that the fire extinguishers have been inspected this month.

Public Works Report:

- James Schilling reported that they have begun working on the sewer jet truck. The injection pump is out and they have priced a replacement part at \$2,500. The Town Council stated that they should hold off on purchasing a replacement as it is unknown what other repairs and parts may also be needed.
- James Schilling reported that the sewer at the shop is backing up. Prairie Plumbing was unable to determine exactly where the problem is. They discovered

that the shop is still hooked on to the old sewer main that goes along Logan Avenue. TruPipe scoped and jetted the old main line, and all seemed ok. They were unable to scope and jet beyond 45 feet of the service line to the shop. They will be looking to run a new service line into the new sewer main which will require dewatering as well.

- James Schilling reported that they have contacted Dakota Fence for an estimate on an updated playground and covering where the tennis court currently is within the park.
- Mayor Rolane Christofferson stated that Bruce Lantis has offered to cut down the marked trees in the park for \$100 per tree. Upon discussion, the Town Council passed a motion to proceed with removing the trees. (Christofferson/Kinsey)

Mayor Rolane Christofferson reported that she is meeting with Dave and Maureen Schwarz to discuss applying for grants for the playground project at the park. She also has learned the process at applying for grants at Stockman Bank has changed and will share that information with Dave and Maureen Schwarz as well.

Town Attorney Rennie Wittman has not heard back from Sheryl at Prairie Abstract and Title with an update on the Warner lot purchase.

There were no submitted building permits.

Clerk Lynn Schilling reported that she is still waiting to here back on the date for the dog/cat vaccination clinic.

Clerk Lynn Schilling reported that no delinquent sewer letters were sent this month.
