

The Terry Town Council held a public hearing for the purpose of hearing comment on Resolution # 2025-505 levying and assessing special assessments for the fiscal year 2026 upon all the property within the Street Maintenance District # 1, for the Special Improvement Districts # 111, 112 and 114 for the purpose of street lighting, and for garbage assessments within the Town of Terry. The Town Council held a final budget hearing for the purpose of hearing comments on the proposed budget for fiscal year 2025-26. Upon conclusion of the public hearings, the Town Council held a special session to consider the adoption of Resolutions 2025-505, 2025-506, and 2025-507. Town Council Members Karlene Kinsey, Scott Christofferson, Neva Rathbun, Clerk Lynn Schilling, and Joan Grammer were present. Mayor Rolane Christofferson presided over the public hearings and special session.

Mayor Rolane Christofferson discussed Resolution # 2025-505, levying and assessing special assessments for the fiscal year 2026 upon all the property within the Street Maintenance District # 1, for the Special Improvement Districts # 111, 112 and 114 for the purpose of street lighting, and for garbage assessments within the Town, and opened the public hearing. There was no public comment.

Mayor Rolane Christofferson briefly discussed Resolution # 2025-507 and the final proposed budget for fiscal year 2025-26 and opened the public hearing. There was no public comment.

Mayor Rolane Christofferson opened the special session for formal consideration of the aforementioned resolutions.

The Town Council passed a motion for the final adoption of 2025-505, levying and assessing special assessments for the fiscal year 2026 upon all the property within the Street Maintenance District # 1, for the Special Improvement Districts # 111, 112 and 114 for the purpose of street lighting, and for garbage assessments within the Town of Terry. The Town Council passed a motion to approve Resolution # 2025-506, Determining the Salaries and Compensation for fiscal year 2025-26. (Christofferson/Kinsey)

Clerk Lynn Schilling provided updated budget documents to the Town Council. The final budget document was available for viewing as well. With no further questions or comments, the Town Council passed a motion to adopt Resolution # 2025-507 adopting the Final Budget for Fiscal Year 2025-26. (Rathbun/Christofferson)

Joan Grammer inquired about property taxes decreasing and how that may affect the Town's budget. Mayor Rolane Christofferson reported that the Town's anticipated revenues are comparable to previous years and that many of the changes were on voted levies which the town does not have.

Having no further comment, questions, or public comment, the meeting was adjourned at 6:34 p.m. (Kinsey/Christofferson)
